During September three crimes were reported including anti-social behaviour on Abbey Croft in Cutthorpe and on the A619 Eastmoor and other theft on Main Road, Old Brampton

For October again three crimes including a burglary and anti-social behaviour on Dunston Road and anti-social behaviour on Piper Lane.

The team Leader of Environmental Enforcement has reported that a joint patrol with Severn Trent Ranger has taken place at Linacre Reservoir to address dog fouling in the area.
