John Heathcote and Mike Sim from the Chesterfield and North East Derbyshire Ramblers explained the loss of the historic arrangements for volunteers to work with a County Council Ranger on the maintenance and improvement of footpaths in Derbyshire. The County Council had withdrawn support for the Ranger around three years ago, meaning that the condition of many footpaths had deteriorated. It was reported that there were 62 footpaths and 12 bridleways within Brampton Parish, totalling around 30 miles.

It was resolved that the Council would work in liaison with the NED Ramblers and explore the possibility of accessing the Minor Maintenance Grant to support them in their work to help maintain the footpaths within the Parish.
