#### b) Police Report / District Councillor / County Councillor

Councillor Elliot informed the meeting that there had been a full meeting at NEDDC and that a budget had been set. The main items in discussion included a push to increase tourism across Derbyshire and this could involve locally Brampton and nearby Walton – he invited ideas from members to put to NEDDC. Speeding is now a major issue across the area – as is parking. However, the pandemic means that NEDDC is prioritising its services to the elderly and vulnerable. The local MP Lee Rowney is looking at the quality of bus services and any members can join in his proposed meeting.

A discussion took place over the planned Speed Watch campaign which is being supported financially by the Derbyshire Police and Crime Commissioner and which Cllr Foster at Derbyshire County Council is supporting.

**Resolved** - The meeting approved the purchase of a speed gun and two signs for when the current restrictions end and the proposed Speed Watch commences across the parish – proposed by CIr Catton and seconded by CIIr Elliot.

#### 109/20-21 Meeting Reports

#### a) i) Cutthorpe Playground and Recreation Ground

Cllrs' Lawrie and Colwill had attended a meeting on site arranged by the clerk with Mark Yates a representative of Huck Tek the company that had installed the play equipment at Cutthorpe playground, including the climbing whirl which had recently been the subject of an incident.. He explained that the ride could be slowed down but experience showed that this takes all of the fun out of the ride and was likely to lead to more complaints that it was too slow. The cost to replace the matting for all rides and put a brake on the ride was £2675 plus VAT and the cost to replace the matting £1620 plus VAT. A discussion took place and the consensus was that slowing the ride down would take the fun out of the ride and defeat the objective of providing a fun experience. The matting is due for replacement after 5/6 years use and this would reduce the risk of injury. All rides had a risk factor and that was part of the play experience. However, members agreed that a sign should be placed on both Cutthorpe and Wadshelf playgrounds to remind parents of the risks involved and to advise against smaller children using the climbing whirl ride.

**Resolved** The clerk will check out the use and wording of a suitable sign and will also check the standing orders regarding proceeding with the Huck Tek quote for matting or whether further quotes should be obtained nothwithstanding in the current pandemic obtaining such quotes is not easy and the Council is keen to proceed to mitigate risk. – **Post meeting note** – standing orders allow the purchase of such equipment given the current urgent need ); where the value is below £3000 and above £100 the Clerk/RFO shall strive to obtain 3 estimates. Otherwise Regulation 10 (3) above shall apply.

# Regulation 10 (3) says 'When applications are made to waive financial regulations relating to contracts to enable a price to be negotiated without competition the reason shall be embodied in a recommendation to the council'

Given problems in finding suitable suppliers during the pandemic a decision was made to accept the quote from Huck-Tek and proceed with the matting as per the above reference.
