#### 116/21-22 Public Speaking

- a) John Robinson informed the meeting that he was trying to raise local support to help any refugees from Ukraine that were relocated to the area. He is hoping to get enough people together in the Parishes of Brampton and Barlow to hold an initial meeting to assess the level of support. There was discussion around various aspects of providing support with the consensus being that the Parish Council could offer support once, and if, any refugees are housed with families in the area. Individuals can register on the government website should they feel that they can offer accommodation to refugees and at this point in time it is unknow how many would be likely to be housed in the locality and consequently difficult to assess how much support will be needed.
  - Cllr Catton is to contact the Clerk at Barlow Parish Council to look further into the holding of an initial meeting in the next couple of weeks. In the meantime, John Robinson will contact Cllr M Thacker to see what the District and County Council proposals are. He thanked the Parish Council for listening to his proposals.
- b) There were no police or district/county councillors in attendance, but an email had been received by Cllr Catton regarding a scheme for the installation of speed notification cameras that were available. Following discussion Cllr Catton agreed to register the Parish Councils interest with the County Council

Cllr Lawrie informed the meeting that if the Parish Council extended the Institute then they would be liable for a payment to be made to the Derby diocese to reflect the uplift in value of the building. Nothing further done on this as yet. He has been doing some additional works on the plans for the outside area which will be brought to a future meeting.

The contractor was looking to start the roof works asap. There was some discussion around potentially needing building regulations approval prior to starting works. The Clerk is to clarify and inform Cllr Lawrie if required. There was some discussion around whether the institute would need to be closed for the 3-4 weeks of the works. Cllr Lawrie is to meet the contractor to discuss further as this may have an impact upon when the works can be done.
