101/22-23 Public Speaking

- a) Member of public introduced himself and explained that he is interested in joining the Parish Council. All agreed and welcomed Charles Ainley. The Clerk will forward the declaration of interest form for completion.
- b) Cllr Elliott shared a few details from the Police and Crime Commissioners annual report. Cllr Thacker said there had been an increase in rural crime activity due to criminal gangs from surrounding major cities. Drug trafficking and modern slavery is now an issue locally. He said that ther had been no improvement in the Hulleys Bus service but believes that discussions are underway to reroute the 170 and x70 services which should result in improvements. Any changes have to be agreed by the County Council.

The County Council currently have a "Grab a Cab" scheme in operation, mainly to help those with medical needs to make medical appointments. The scheme is in operation until the end of March, Monday - Friday 9 to 5. Contact number is 01629 536175. The District Council is also running a warm places scheme to help with the cost of living. They are working with Parishes to try and identify suitable locations

Cllr Phipps reported that there is only occasional use at present but need to book in the electrical tests for both venues.

a) Cutthorpe Playground and recreation ground

Cllr Lawrie said that he expects to hear from Viridor this week with a decision on the grant application. There has also been a donation from a local family for an additional bench

b) Wadshelf Playground

Cllr Phipps said that Wicksteed are meeting him at the play area later this week to look at the fencing.

c) Works

- i) Cllr Lawrie said the new grit bin was now in place on Common Lane but required filling and the old one removing. The Clerk will ask the contractor.
- ii) Cllr Catton mentioned the increasing number of potholes. Cllr Elliott said that anyone can report them on the County Council website

d) <u>Parish Plan</u>

Cllr Catton said that the plan needs a hard copy printing ready for public consultation. He is happy to hold at his home. Two Councillors volunteered to print. He mentioned that no response had been received from the PDNPA yet but he would chase for a response.

106/22-23 Parish Council Liaison with County and District Councils

Cllr Wood raised the issue of cars parking round the bend and on the pavement at Four Lane ends causing problems with obscuring vision and for pedestrians. Cllr Elliott also said the speed limit signs are obscured and could do with being re-sited 10m towards Barlow. The Clerk will raise both issues with the County Council and the police.
