a) Mr Jonathan Shedd and Mr Tony Darwent attended the meeting to raise their concerns regarding the NEDDC's identification of potential sites for development, particularly in Cutthorpe.

A group of residents has been established within the Granary Estate and Cutthorpe Area and they have raised their concerns regarding the call for sites but also, the lack of communication.

Councillors Thacker informed Mr Shedd and Mr Darwent that both he and Cllr Elliott have made objection to all sites in Cutthorpe and Brampton, as has the Parish Council.

Cllr Thacker gave advice on how residents should raise concerns in the future. He informed the meeting that this is phase one, If there is a phase two and Cutthorpe is still involved then it will be necessary to have another meeting in the New Year. The importance of good communication was acknowledged.
